Dear Mr. Hendricks,

The 634 page "Domestic Terrorism Book" found on the disk you have requested contains intelligence information on individuals and suspected criminal affiliations; this record is exempt from disclosure.

Specific intelligence information and records compiled by law enforcement, the nondisclosure of which is essential to effective law enforcement, is protected from disclosure. RCW 42.56.240. For that matter, it is also unlawful to divulge investigative information pertaining to activities related to organized crime which is obtained through public employment. RCW 43.43.856, *see also* RCW 42.17.310(D), RCW 10.97.050, and Code of Federal Regulations 28. The requested Domestic Terrorism disk states this on its surface.

I am providing you with a 1-page "Notice" concerning the contents of the disk, which is produced to you without redactions of any kind. I am also providing you with a list of attendees to the training. Employee personal email addresses are exempt from disclosure and have been redacted from the list. See RCW 42.56.250(3). Finally, also attached is a copy of an email from Washington State Patrol to attendees of the 2006 Domestic Terrorism Conference containing the password to the disk. The password itself has been redacted pursuant to RCW 42.56.420.

Also attached is the expense report for the staff member that attended the training course. He is the only member that attended from the Vancouver Police Department staff.

This will conclude the city's response to your request.
