(U//FOUO) This is the third known attack by A.L.F. in the past 14 months in Oregon.

On October 11, 2010, another Clackamas County cervid farm was targeted (Molalla, OR). However, none of the European Fallow deer fled through the destroyed fence. View the Oregon TITAN Fusion Bulletin regarding that incident: [ALF Claims Molalla Deer Farm Release.](#)

(U//LES) According to Clackamas County Sheriff Office TITAN representative, Lt. Chuck Slaney, the modus operandi between this incident and the Molalla event last fall is similar. Approximately 100' section of wire fencing was completely removed at the post line. Several cow elk and one bull elk from the Damascus farm were discovered in neighboring property, but returned to the farm without incident.

Oregon TITAN Fusion Center Note: *While this incident caused minimal property damage and no reported injuries, A.L.F. activists have caused major damage and injuries in previous “liberations”. Officers are reminded to use caution when responding to such calls as incendiary devices have been used in previous incidents. Please report any suspected animal activists / extremists incident to the Oregon TITAN Fusion Center.*
