Victim says Mumin is a, "mid-level drug dealer" who always carries a firearm. Weapon in this case has not been recovered. Considered armed and dangerous.

If located, take his cell phone for evidence. If in a vehicle, seal that and arrangements will be made to have it towed to Tukwila.

Superform for Mumin is in Ingress.

The only vehicle registered in DAPS to Mumin is a White 2006 Cadillac CTS WA LIC/BIV4671. This vehicle was stopped by Renton PD on 6/5/19 but the occupants said the vehicle was recently purchased and the title wasn't transferred yet.
