On 6-06-19 / 0420 hours, a non-injury shooting occurred at the Villa Capri Apts (28621 25th Pl S) in Federal Way. An unknown male fired 4 shots towards unit #B-208 and then fled in a red colored compact car, unknown license plate / make / model. #B-208 is the residence of Martin L. Mendoza 4-21-1986 and Delana L. Brooks 10-07-1992. Officers arrived and conducted an area check and recovered two abandoned handguns, a Springfield XD 9mm and Taurus 38 special. The Springfield XD was confirmed as stolen from a Puyallup area burglary (Puyallup PD case 1913200997).

A witness identified Stacy Ramon Samuel II as someone seen on the second floor of another apartment building pointing a black handgun down at the officers and tracking them as they were doing their area checks. The officers were unaware of Samuel's actions. Samuel is known to frequent Villa Capri and may be affiliated with #B-208. At this time, there is no probable cause to arrest Samuel for any weapon or assault crimes but he currently has a DOC warrant for Escape.
